	The vacancy is within the Knowledge for the Energy Union Unit of Directorate C - Energy, Transport & Climate, with a mission of providing, through knowledge management, scientific and technical support to EU policies related to the Energy Union strategy implementation, most notably on its research, innovation and competitiveness pillar. Our staff (about 50) is mainly based in Petten (NL).
	The successful candidate will support the design and development of platforms for using and sharing data and knowledge in support to policy making. The candidate will assess the data and information needs for supporting the implementation of the Energy Union, develop an inventory of available information in the JRC and the Commission at large, and identify eventual knowledge gaps.
	Specific tasks will include:
	• Design, development and provision of tools and methods for the collection, analysis and dissemination of relevant data and information for the Governance of the Energy Union.
	• Development of information systems of Dir. C including a knowledge sharing platform which will facilitate easy access (one-stop-shop) and better knowledge management.
	• Carry out a user survey amongst policy makers concerned with the Energy Union to identify their current and future data needs and perform a gap analysis to identify the data needs and priorities thereof.
	• Establish contacts within and outside the European Commission for knowledge sharing.
	Qualifications:
	The ideal candidate should have a completed university degree in Engineering, Economics or Science of at least three years duration attested by a diploma, and at least

	five years of professional experience or, alternatively, a PhD degree preferably with research experience in the relevant fields. Prior knowledge in data management and/or knowledge transfer is desired.
	Good knowledge of database and information systems, data management tools and programming languages (e.g. MySQL, PHP) would be an advantage.
	We look for a person with strong interest in data management and knowledge management issues, who will have a good aptitude of taking initiative, developing new concepts and be a strong team player.
	This position offers a number of varied and interesting tasks in a friendly and well integrated Unit to a motivated, flexible and reliable colleague.
	Very good command of English (B2) is essential. English Language level "C1" is an asset and will be tested on the day of the interview to evaluate if the knowledge/level is fulfilling the needs of the service.
