Duties of the Post

Clinical

- The proposed timetable will contain six fixed sessions. The post-holder will have four theatre sessions and two critical care sessions each week. The remuneration is 10 PAs this includes recognition for the increased requirement due to direct patient related administration and out of hours recognition for predictable and unpredictable work.
- Other duties will involve pre- and post-operative ward rounds, audit, teaching, on-call duties and other department functions.
- Consultants undertake the administrative duties associated with the running of the department and are responsible both single, and corporately, for the management of junior medical staff, their training and professional development.
- All consultants take part in the on-call rotas and full internal cover is expected for consultant leave. The ITU has 8 Consultants covering 24 hours 7 days per week (1 in 8) and the other 14 Consultant Posts cover Theatres and Maternity (1 in 14).
- The Critical Care runs daily multidisciplinary ward rounds, from 08.00 every day of the week including Saturday and Sunday.
- The Trust is also expected to participate in a series of localised networks, which may necessitate a greater element of on-call cover.

Organisational

- Having a continuing responsibility for the care of patients in their charge and for the proper functioning of their departments.

- Undertake the administrative duties associated with the care of their patients and the running of their clinical department.
- All consultants are expected to assume responsibility both singly, and corporately, for the management of junior medical staff. In particular, they are expected to be responsible for approving and monitoring junior staff locum arrangements, where appropriate.
- They are also expected to concern themselves with the professional development, both clinical and personal, of their trainees.
- Mandatory involvement in appraisal on an annual basis
- To undertake managerial and budgetary responsibilities as required

Teaching & Training Activities

There is an expectation that part of this job should involve ongoing teaching and training of primary care colleagues through group teaching and practice-based sessions in order to disseminate specialist skills and provide a forum for the discussion of case studies and set clinical guidance.

The hospital has University status. Consequently the training of medical students, junior hospital doctors, nurses and physiotherapists has a high priority. The new colleague will be actively encouraged to pursue any interest in this area.

Clinical Governance is a major part of our daily practice. The hospital has a dedicated, separate department with allocated clinical and administrative staff to facilitate this.

There is a well-stocked medical library with audio-visual teaching aids, CD-ROM and a full time librarian. The library has a Medline facility. There is a thriving Postgraduate Medical Centre with regular clinical meetings and a general education programme.

All consultants are expected to take advantage of study leave to maintain and develop their clinical skills to comply with CME requirements.
